Civil Aviation Authority of Nepal, Rescue and Fire Fighting Department (RFFD) hereby invites electronic-bids from eligible bidders for the procurement of ***The Supply, Delivery, Testing & Commissioning of ARFF Vehicle for Simara Airport*** under International competitive bidding procedures specified in Public Procurement Act and Regulations.

4. Pre-bid meeting shall be held at RFF Department, Civil Aviation Authority of Nepal at 15 days prior of the bid submission date 20 Feb, 2020 at 12:00 noon LT.
5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp within 5 march, 2020 before 12:00 (Nepalese Standard time). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend within 5 march, 2020 at 14:00 pm (Nepalese Standard Time) of Civil Aviation Authority of Nepal, RFF Department, Babarmahal, Kathmandu. Bids must be valid for a period of 120 from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 23,75,000.00** or equivalent foreign currency, which shall be valid for 30 days beyond the validity period of the bid documents.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
