1. Civil Aviation Authority of Nepal (CAAN) intends to take consultancy services for physical verification of Property plant and equipment's (PPE) and Fair valuation of movable & immovable property of civil aviation authority of Nepal (CAAN) based on NFRS requirement.
2. The Expression of interest (EOI) is invited from interested eligible national Chartered Accountancy consulting firms in technical assistance with individual/firms.
3. Interested eligible Chartered accountancy consultant should submit EOI within 15 days of first publication of EOI notice and may obtain further information & EOI documents free of cost at E-gp system www.bolpatra.gov.np/egp.
4. If the deadline of EOI submission falls on government holiday, it will be extended automatically to the next working day at the same time. The EOI documents received after the due date and time shall not be accepted.
5. The EOI documents received by due date and within specified time will be opened at 12.00 (NST) on 16th day of first date of publication of this notice in presence of the applicants or their authorized representative, who choose to attend. Absence of the applicant or their representative, however, shall not prevent the opening of the EOI documents.
6. The EOI documents submitted by the applicants shall be evaluated on the basis of the evaluation criteria approved by the CAAN. For short listing purpose the combined experience of the consultants with its association will be evaluated. The shortlisted consultants will be notified in due course of time for the submission of Technical and Financial proposal. The quality and cost based selection procedure (QCBS) will be used for the selection of the consultant.
7. The interested CA firms shall submit the following information with the application of EOI:
 - CA firm having minimum 7 years of experience in related field.
 - Firm Registration Certificate & its upto date renewal.
 - VAT Registration Certificate and submission of VAT return on regular basis.
 - Tax clearance certificate up to FY 2076/77 or Submission of income tax return for FY 2076/77
 - Experience in relevant assignment.
 - Experience in NFRS based physical verification and Fair valuation jobs in public sector entities.
 - Experience in NFRS based Audit experience in public sector entities.
 - Special requirement as advantage : The CA consulting firm having Experience in NFRS assignment in the government entity/Institutions shall be added advantage.
 - Sufficient qualified professional staff/Experts (Local & foreigner) to carry out defined tasks.
8. Minimum score to pass in EOI Should be obtained 70 out of 100 marks.
