Coverage of hotel quarantine cost (up to 14 days) and medical expenses (NPR euivalent to US \$5000), if needed, of all age-groups of passenger if diagnosed with COVID-19 whilst travelling, and

 Claim, validity and payment of insurance policy of passengers with local insurer at Nepal.

Furthermore, you are requested to inform this office about the development of aforementioned provision within seven (07) days and this letter supersedes all the previous circulars regarding the same subject.

Sub: About the COVID-19 Insurance Coverage of Air Traveller

As a further illustration to the letter with Ref.No.078/79- DDG2/D.No. 1599 dated 03 Dec 2021 of this authority, CAAN clarifies the following facts;

- COVID-19 insurance policy has to be done by Airlines, not the individuals or the travel agencies.
- 2. After the contract between the Airline and Insurance company, airline can activate this policy.
- 3. The policy should cover the isolation charge (up to 14 days) and medical expenses (up to US \$5000), in case of hospitalization.
- 4. The coverage of isolation charge per day may vary subject to the types of hotels/accommodation stays of concerned airline.
- This insurance policy aims to boost air travel integrity of passengers amidst different variant of COVID-19 and is circulated as per the instruction of Ministry of Culture, Tourism & Civil Aviation.
