One Thousands) + VAT Each **Package A and B** in cash or in form of bank receipt for fee deposited in **Account Number 58** in cash at Rastriya Banijya Bank, TIA Branch, Gauchar, Kathmandu.
4. Each Wax Sealed/Stamp Bids must be submitted to the above office Tribhuwan International Airport Civil Aviation Office on or before 12:00 on 2073-12-07 Documents received after this deadline will not be accepted.

Each bids shall be opened in the presence of Bidders or Bidder's representatives who choose to attend 14:00 on the 2073-12-07 at the office of Procurement Section, Tribhuwan International Airport Civil Aviation Office, Procurement Section, Gauchar, Kathmandu. Bids shall be opened even in the absence of the bidders or their Authorized representative (s).

Each bid must be accompanied by a separate Bid Bond in the form of a bank guarantee of the Nepalese 'A' Class Bank or Bank Voucher of cash deposited at Rastriya Banijya Bank, Branch Office TIA, Gauchar, **Account No. 70** for an amount of **NRs. 55,000/- for package A and NRs. 40,000/- for package B.** Successful Bidder shall be required to furnish a Performance Bond accordance with the prevailing Public Procurement Act, 2063 and Public Procurement Regulation, 2064 before signing of Contract.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever prior to award of contract.
