The bidder shall have to present the copies of the letter of authorization awarded by respective Airlines to sell their air tickets. All the certificates shall be notarized by Notary Office.
- 4. Bidder shall have minimum of 5 (five) years of experience in International Air Ticketing Service.
- 5. Bidder shall have minimum of NRs. 3,22,50,000 (Rs.Three Crore Twenty two Lacs Fifty Thousand) financial turnover per annum in the last three fiscal years.

All Bids accompanied by a Bid bond as specified below must be delivered in accordance with the Instructions to Bidders at or before 12.00 hours local time on or before the dates and address given below.
